#### **Role Overview**

Ensure compliance with legal, regulatory, and ethical obligations, including OSCR guidelines.

#### **Board Management**

Chair Board meetings effectively, ensuring all voices are heard and decisions are well-informed. Foster a collaborative and engaged Board, recruiting and developing trustees as needed.

Oversee financial sustainability and risk management alongside the Treasurer and Board.

#### Strategy & Advocacy

Guide the development and implementation of the charity's strategic vision.

Represent and advocate for the charity with key stakeholders, funders, and the public.

Support fundraising efforts, partnerships, and campaigns to enhance the charity's impact.

#### Support & Oversight

Act as a sounding board for the Chief Executive or operational staff/volunteers.

Ensure effective succession planning within the Board and senior leadership.

Mediate and resolve any governance issues within the charity.
